2) General Education Update

Dr. Henderson has asked the Senate, Dr. Ansley Lamar, Interim Director of General Education, and the General Education Executive ad hoc Committee to assist in creating a profile for the new General Education Director so that a search can begin in the near future. The Office of the Senate will communicate more details in the near future.

VI. Remarks & Campus Updates: Dr. Sue Henderson, NJCU President

Dr. Henderson acknowledged the Senate for the progress of the General Education program, and identified three priority initiatives to be addressed by the Senate:

- Refining the course and program approval processes
- Writing, Speaking and Quantitative Reasoning Across the Curriculum
- Refining the Academic Integrity Process

Total enrollment has remained steady: a decrease in undergraduate enrollment has was offset by an increase in graduate enrollment. Increased focus on undergraduate recruitment includes extending our efforts to Maryland, Connecticut and Delaware, and to additional high schools. The searches to fill the new position of Provost/Chief Academic Officer and new faculty are under way.

Dr. Henderson has been meeting with state officials to discuss the impact of the planned Pulaski skyway lane closures on NJCU students and faculty. Administration will work with staff and the state to propose alternative solutions to adjust to the closures and minimize impact.

Dr. Henderson provided a brief report on the meeting of the New Jersey Presidents' Council regarding workforce development. After reviewing current employment data and future projections, a key question for NJCU and other New Jersey institutions of higher education is "What does an educated person need to succeed?"

Dr. Henderson introduced interim Provost Dr. James Muyskens. He is focusing on the University's two part strategic goal: raising academic quality (improving learning outcomes), and improving retention and graduation rates.

Dr. Muyskens reviewed the demographics of NJCU students, and noted that the 2014 progress report targets a one year retention rate of 75%, and six year graduation rate of 39%. He also noted that 73% of all classes (day and evening, upper and lower division) meet only once a week. Increased opportunities for student interaction with faculty will have a positive impact on both retention and graduation rates. A goal of Dr. Muyskens is that students will say on student satisfaction surveys that a hallmark of NJCU is the rich interaction that occurs between students and faculty. To achieve this goal, priorities include:

- Build upon work already done by the two retention task forces (academic and student affairs)
- Look at the currently successful on-campus programs [Athletics, OSP, Honors Program...]
- Develop Gen Ed to maximize opportunities for student/faculty engagement
- Revamp the class schedule.

VII. Astronomy Minor Proposal

The motion to approve the Astronomy Minor Proposal was unanimously adopted.

VIII. Senate Standing Committee Reports

a) Curriculum & Instruction Committee

Dr. Chris Cunningham, Chairperson, presented the committee's Recommended Guidelines for New Minor Proposals:

The Curriculum and Instruction Committee is recommending the following guidelines for proposed minor programs:

- 1) A separate proposal form should be developed for minor programs.
- 2) On the proposal form, minor programs should be designated as either department-based, multidisciplinary, or interdisciplinary.
 - Multidisciplinary minors are programs not attached to a discipline-specific department but organized as a collection of discipline-specific inquiries into an object or topic.
 - Interdisciplinary minors are minors that adhere to a methodology or approach transcending discipline-specific ones. They therefore must include an introductory course.
- 3) Multidisciplinary and interdisciplinary programs should include, for signature on the proposer line, representatives of all participating departments.
- 4) Multidisciplinary and interdisciplinary minor programs are to be chaired and housed by agreement of the participating departments.

The Committee furthermore proposes the following structure for proposals themselves, to be immediately posted on the Senate website:

- 1) **Catalog Description**. Please provide the description of the minor program that will appear in the University catalog.
- 2) **Rationale**. Please provide the rationale for the creation of this program
- 3) **Student Learning Outcomes**. Please provide, using single verbs from Bloom's taxonomy, expected student learning outcomes for the proposed program.
- 4) **Assessment Structure**. Please describe the plan, tools, and timetable for assessing the program.
- 5) **Program Structure**. Please describe the curricular and administrative structures of the proposed program.
- 6) **Resources**. Fully detail the resources necessary for the creation, implementation, and maintenance of the proposed program.

A motion to amend the proposal to grandfather proposals for new minors submitted to the Senate prior to approval of these guidelines was made and seconded. The grandfather clause was adopted by a vote of 29-14. The amended proposal was adopted by a vote of 39-3.
