University Senate Meeting Minutes University Senate Meeting #1, For AY 2013-2014 Monday, September 16, 2013, Gothic Lounge

The Senate President, Dr. Karen Morgan Ivy, called the meeting to order at 3:07 p.m.

A moment of silence was observed in the memory of the tragic passing of Ashley Sara Chieco, an outstanding graduate student in our psychology diploma program, on Friday, August 16th from injuries sustained in an automobile accident. Ashley was an NJCU alumna who earned an M.A. in Educational Psychology in May 2012.

Dr. Ivy also referred to an e-mail sent on Wednesday, August 21, 2013 NJCU staff distribution list on behalf of Dr. Henderson regarding the passing of our retired colleague Helen T. Webber on Thursday, August 19th. Helen retired as an associate professor of Sport and Leisure Studies in 2000, having served as a faculty member for over 33 years. She had been an active member of the College Senate, having served as a Senator, Senate Secretary, Vice Chair, and chair of the Academic Standards, Faculty Affairs, and Student Concerns Committees.

V. President's Report:

It was brought to the attention of the Senate President and the Executive Committee that an oversight took place during the May reorganization meeting.

Dr. Ivan Steinberg was a member on the Senate Elections Committee with one year remaining to complete his term on the Committee. During the reorganization meeting, Dr. Steinberg was nominated from the floor of the Senate and elected to serve on the Senate's Planning, Development & Budget Committee. However, the Elections Committee and the Senate office did not receive a written resignation from Dr. Steinberg. Thus, it would be expected that Dr. Steinberg fulfill his commitment to complete his term on the Senate Elections Committee. These procedures were adopted and approved at the Senate meeting on 21 March 2011.

VI. Remarks, Campus Updates and Introduction of New Hires: Dr. Sue Henderson, NJCU President

Dr. Henderson presented remarks and campus updates that normally would have been given at the All University Meeting. The All University meeting was combined with the first Senate meeting because of the September 20th convocation and inauguration and accompanying events which were to take place at the end of the week. Dr. Henderson presented highlights of our accomplishments and briefly reviewed the most pressing issues in the higher education landscape. Included were remarks on the FY 2014 budget, Fall 2013 enrollment figures, capital projects, and a discussion of the Institutional Effectiveness Progress Card, which measures the effectiveness of NJCU from year to year. VII. Old Business

General Education Program Proposal: A progress report was given by Dr. Fran Moran who summarized the changes made to the proposal as a result of town hall feedback and meetings with faculty held in June 2013. The revised proposal with a summary of the changes was distributed to the Senate by Donna Piscopo on behalf of Dr. Ivy on September 11, 2013. Dr. Moran requested that senators share the revised proposal with their constituents, and that a vote on the proposal be conducted at the October Senate meeting. It was agreed that discussion would be allowed prior to the vote, and that Dr. Moran will relay any amendments made to the proposal in advance of the meeting.

VIII. New Business

Dr. Gloria Boseman presented a motion that the record reflects the historic occasion of Dr. Karen Morgan Ivy as the first African American/African American Woman to preside over the New Jersey City University for the 2013-2014 academic year, and do so with confidence in her capable leadership and pride in the University affirmation of power in diversity. The motion was seconded and unanimously approved.

A concern was raised that contrary to procedure followed in previous Senate meetings, green placards which identified voting Senators were not distributed. It was agreed that voice votes would first be held, and a way of identifying Senators when a physical count was needed will be implemented.

Dr. Henderson noted that other Vice Presidents also had newly hired staff to introduce, and would do so at the next Senate meeting.

The meeting was adjourned at 4:21 P.M.
