

## 2023-2024 Verification Worksheet – Dependent Student

Your 2023–2024 Free Application for Federal Student Aid (FAFSA) was selected for verification. Verification is the process used to confirm that the data reported on your FAFSA form is accurate. **D. TAX RETURN NON-FILERS**
