## **Exploring the Heart of Maritime Commerce: ASCM NJCU Student Forum Harbor Cruise**



On Sunday, October 20, 2024, the [Association for Supply Chain Management \(ASCM\) NJCU Student Forum](#), with support from the [NJCU-KMI Center for Supply Chain and Maritime Logistics \(CSCML\)](#) and the [NJCU School of Business](#), hosted an exclusive harbor cruise to give students a firsthand look at one of the world's busiest ports. This immersive experience brought six NJCU students face-to-face with the vast scale and complexity of the New York and New Jersey harbors, offering a valuable educational and networking opportunity.

Guided by Bethann Rooney, Director of the Port Department at the Port Authority of New York and New Jersey, participants explored the port's pivotal role in global commerce and its evolution. Rooney, a maritime industry expert with over 30 years of experience, provided a rich narrative on the port's history, from its early wooden piers to the high-tech infrastructure of today. Highlights included views of container terminals, the iconic Lower Manhattan skyline, and the Statue of Liberty.

The tour, organized by Open House New York, emphasized the port's role as a gateway to a major consumer market, as well as its transformation to meet modern supply chain demands. Students left the event with a deeper understanding of port operations, improved networking connections, and enhanced team-building skills.
