# **1. INFORMATION FOR BIDDERS**

#### 1.1 BACKGROUND

New Jersey City University (NJCU), located in the City of Jersey City, is one of the nine state colleges and Universities in New Jersey. The University opened its doors as the New Jersey Normal School of Jersey City on September 12, 1929, with 331 students and one building on campus, Hepburn Hall. Eighty years later, more than 8,000 degree-seeking students enjoy the fifty-two acre campus, which now features fourteen buildings. The mission of New Jersey City University is to provide a diverse population with an excellent university education. The University is committed to the improvement of the educational, intellectual, cultural, socioeconomic, and physical environment of the surrounding urban region and beyond. Through implementation of its mission, New Jersey City University has realized its vision of becoming a nationally recognized leader in urban public higher education. New Jersey City University is committed to its urban mission by: sustaining, celebrating, and promoting academically an understanding of community diversity; tapping the rich resources of the urban setting and cultures for the benefit of its learners; and employing its knowledge resources, via faculty and students and with partner organization, to identify and solve urban challenges.

NJCU is also creating a 21-acre University Place Development, which will blend academic buildings, recreational facilities, and mixed-use residential, retail, and commercial space with landscaped public areas and walkways. In expanding its campus, NJCU expects to create an urban village that will enrich the surrounding neighborhood and will encourage its neighbors to enjoy the shops, theatre and performing arts programs, cafes, and public outdoor spaces that are part of the plan. The site is bordered by Route 440, West Side Avenue, Carbon Place and the Home Depot Property. Construction began in 2012 with the development of the infrastructure, including placement of sewer lines, utilities and streets. The final stage, the construction of buildings, will be handled in phases.

#### 1.2 PURPOSE AND INTENT

Pursuant to N.J.S.A. 18A:64-54, New Jersey City University ("NJCU" or the "University") is issuing this document, a Request for Proposals ("RFP") for Commercial Banking Services from qualified federally insured financial institutions.

The University considers any information which it may have released either orally or in writing prior to the issuance of this RFP, to be preliminary in nature and the University shall not be bound by such information.

The University's obligation is contingent upon the availability of funds.

#### 1.2.1 CONTRACT TERMS

The intent of this RFP is to award a single or multiple contracts to responsible bidder(s), whose bid, conforming to this RFP, is most advantageous to NJCU, considering price and other factors. New Jersey City University intends to award the contract for one (1) year commencing from the date of award renewable at the option of the University for four (4) additional one (1) year terms.

If, at any time during the term of this award either the University or the vendor considers terminating the agreement, they shall give the other party written notice that it is considering such action, which notice shall set forth with sufficient specificity such party's reasons for contemplating termination. During the following thirty- (30) day period the parties shall discuss, in good faith, the party's reasons for considering termination in an effort to avoid the need for such action. Following the thirty (30) day discussion period, the party considering termination, if not fully satisfied, may elect to terminate the agreement by giving the other party thirty (30) days written notice.

Should additional work be required, which is beyond the scope of this RFP but is related to the overall contract, the vendor will be requested to submit a written proposal and upon approval, a purchase order will be issued to authorize the work.

## 1.2.2 SUPPLIER DIVERSITY

New Jersey City University recognizes the importance of supplier diversity in its procurement practices. The University has a diverse student, staff and faculty population. In conjunction with the University's overall commitment to diversity and inclusion, the University is committed to contracting with qualified suppliers from all parts of the business community in procuring needed goods and services. By encouraging the participation of Small Business Enterprises (SBEs), Minority Business Enterprises (MBEs) and Women Business Enterprises (WBEs), collectively SMWBEs, in the procurement process, the University strengthens contracting opportunities for SMWBEs, while at the same time providing a value added strategy that increases competition to ensure that the University's funds are maximized.

NOTE: If questions are directed to any University employee other than the aforementioned designees your firm will be disqualified from further consideration.

#### 1.3.2 SUBMISSION OF BID PROPOSAL

In order to be considered for award, the bid proposal must be received by Procurement Services at the appropriate location by the required time in a sealed envelope. The date and time is indicated on the cover sheet. To respond to this proposal, vendors should: Submit one (1) hard copy marked original, three (3) additional hard copies, and one (1) digital copy on either CD or flash drive of its proposal in accordance with the bid submission deadline contained herein, which must be received no later than **2:00 PM on May 31, 2018** to the following location:

Responses received after this time and date will not be considered. E-mailed and/or faxed proposals will not be accepted. The University is not responsible for lost or misdirected documents. Bids must be enclosed in a sealed envelope/package bearing the name of the Bidder and **RFP # 18-011** clearly marked on the outside of the envelope.

The prospective bidder assumes sole responsibility for submitting a complete bid proposal in response to this RFP. No special consideration will be given after bid proposals are opened because of a bidder's failure to comply with all requirements of the RFP.

## 1.4 ADDITIONAL INFORMATION

#### 1.4.1 BIDDER RESPONSIBILITY

The University assumes no responsibility for the completeness or the accuracy of any information presented in this RFP, or otherwise distributed or made available during this procurement process, except as expressly stated to the contrary. Without limiting the generality of the foregoing, the University will not be bound by or be responsible for any explanation or interpretation of the proposed documents other than those prepared in writing. In no event may a Proposer to this RFP rely on any oral statement made by the University or any of the University's agents, employees, advisors or consultants.

Should a Proposer find discrepancies in or omissions from, this RFP and related documents, the Proposer shall immediately notify the University, in writing, and a written addendum of instructions, if necessary, will be emailed to each Proposer. Every Proposer requesting an interpretation of this RFP will be responsible for delivering such requests to the University in writing and within the time limit set forth in Section 1.3

The University considers any information which it may have released either orally or in writing prior to the issuance of this RFP to be preliminary in nature and the University shall not be bound by such information.

Proposers should satisfy themselves, by personal investigation and any other means they deem necessary, as to the conditions affecting the proposed Project and the cost thereof. Proposers are solely responsible for conducting their own independent research and due diligence for their preparation of the Proposals and the subsequent delivery of services under the Project Documents.

#### 1.4.2 COST LIABILITY

The University assumes no responsibility and bears no liability for cost incurred by a bidder in the preparation and submittal of a bid proposal in response to this RFP.

#### 1.4.3 CONTENTS OF BID PROPOSAL

Subsequent to bid opening all information submitted by a bidder in the bid proposal is considered public information, except as may be exempted from public disclosure by the Open Public Records Act [OPRA], N.J.S.A. 47:1A-1 et seq., and the common law.

The University reserves the right to complete its evaluation process prior to making bid tabulations available, through OPRA requests.

#### 1.4.4 PRICE ALTERATION

Bid prices must be typed or written in ink. Any price change (including "white-outs") must be initialed. Failure to initial price changes shall preclude a contract award from being made to the bidder.

## 1.4.5 BID ERRORS

A bidder may request that its bid proposal be withdrawn prior to bid opening. Such a request must be made, in writing, to the Associate Vice President of Business Services. If the request is granted, the bidder may submit a revised bid proposal as long as the revised bid proposal is received prior to the announced date and time for the opening of the bid proposals and at the place specified.

If, after the opening of bid proposals but before contract award, a bidder discovers an error in its bid proposal, the bidder may make written request to the Assistant Vice President of Business Services for authorization to withdraw its bid proposal from consideration for award. Evidence of the bidder's good faith in making this request shall be used in making the determination. The factors that will be considered are that the mistake is so significant that to enforce the contract resulting from the bid proposal would be unconscionable; that the mistake relates to a material feature of the contract; that the mistake occurred notwithstanding the bidder's exercise of reasonable care; and that the University will not be significantly prejudiced by granting the withdrawal of the bid proposal.

If, during the evaluation of bid proposals received, an obvious pricing error made by a potential contract awardee is found, the University's Contract Administrator shall issue written notice to the bidder. The bidder will have five days after receipt of the notice to confirm its pricing. If the bidder fails to respond, its bid proposal shall be considered withdrawn, and no further consideration shall be given it.

If it is discovered that there is an arithmetic disparity between the unit price and the total extended price, the unit price shall prevail. If there is any other ambiguity in the pricing other than a disparity between the unit price and extended price and the bidder's intention is not readily discernible from other parts of the bid proposal, the Contract Administrator may seek clarification from the bidder to ascertain the true intent of the bid proposal.

# 2. SCOPE OF WORK

The University currently maintains six accounts for the following purposes:

- General Deposit Account
- Payroll Account
- Escrow Account
- Operating Account
- Student Refund Account
- Federal Perkins Loan Checking Account

Most of the accounts can make or accept transfers to or from the State of New Jersey Cash Management Fund. The deposit account is used for all the University's deposits and no checks are written against this account.

Currently, the University uses compensating balances to cover bank service fees.

The University currently uses compensating balances to cover bank service fees. However, we wish to explore using a controlled disbursement arrangement and paying directly for bank charges. Please respond using compensating balances and also a controlled disbursement arrangement, as well as current policies. The University is not asking for collateral at this time.

The University processes its payroll through the use of PeopleSoft software. The direct deposit for payroll is currently being transmitted via FTP bi-weekly.

The University would like the capability and the flexibility of using a PC or Web based system to make ACH vendor payments and remote deposits.

The University currently receives its cancelled checks for all accounts on CD-ROM. The University would continue to require one (1) monthly CD-ROM, software, or online capabilities to obtain images of all cancelled checks (front and back), and to be able to research past items and transactions on line. This software must have printing capabilities and included as part of the quoted price for this service. There is currently one Automatic Teller Machine located in Rossey Hall. Please provide information regarding the timeliness of researching transactions and related costs

The vendor shall provide a company representative that will:

- 1. Ensure timely delivery of various reports as requested by the University.
- 2. Ensure timely delivery of replacement and/or new cards.
- 3. Assist in resolving billing/invoicing questions and concern.

#### 2.1 <u>MINIMUM SERVICES REQUIRED FOR NEW JERSEY CITY UNIVERSITY</u>

The successful proposer (hereafter referred to as the "Financial Institution") shall, at minimum, provide the University with the following services:

- a) Monthly statements with ARP (Account Reconciliation Plan).
- b) Full service ATM located on the University campus.
- c) Uninterrupted direct deposit services.
  - i. Direct deposit service should not be disrupted if funds do not exist in that account but compensating balances exist in another University account.
- d) Provide zero balance accounts.
- e) Capability for on-line financial transactions and inquiry.
- f) ACH/wire transfer services.
- g) Capability to provide compensating balances to reduce bank fees.
- h) Competitive bank fees beyond the first year of the contract.
- i) General Depository and Disbursement Accounts.
- j) Positive Pay Capabilities.
- k) Remote Deposit Capabilities.
- I) Special employee benefits such as credit cards, online banking options, and no fee banking contingent upon direct deposit.
- m) Cash Pay/Direct Check card capabilities
- n) Availability of a line of credit for lease purchase financing.

#### 2.2 NARRATIVE SUBMISSION DETAILS/BANKING SERVICES

A narrative describing the Financial Institution's service proposal shall be included in the submission. The narrative should address the following:

Describe and detail the banking services that your Financial Institution intends to make available to the University. Please describe any special features of your services that you believe would be of assistance to the University and that distinguishes you from other institutions.

Indicate how your Financial Institution intends to coordinate its banking relationship with the University. This should include which branch would be used and the names and titles of the

current employees who would be the primary contact persons or representatives to the University.

Briefly describe your Financial Institution's commitment to providing banking services in New Jersey. Please provide a list of regional commercial clients with banking activity that is similar to or greater than the University's annual activity.

Please provide narrative on how you intend to facilitate the smooth transfer of banking activities to your institution so that the University is provided with uninterrupted financial services, including uninterrupted direct deposit activities.

Please include a list of all fees.

Please indicate how any funds deposited through your institution (including VISA/MasterCard transactions) will be made available to the University. Specifically, please indicate the timing in the availability of funds and any process that the University must undertake to access these funds.

Detail the on-line services that the University would be able to access through your institution via the web. Include any transactional, annual and start-up expenses associated with these services.

Indicate how your Institution would handle the transition of the Automatic Teller Machines. Indicate what percentage of fee revenues that the University will receive from the Automatic Teller Machines usage.

Discuss your Business Continuity Plans and practices as well as Disaster Recovery Plans.

Please provide a current rate on your institution's "Government Money Market Mutual fund" and indicate how often the rate is reset as well as a 24 month rate history.

Please provide a current rate of interest on checking accounts and indicate how often the rate is reset as well as a 24 month rate history.

Please indicate if there is a minimum balance required in account to collect interest.

Provide the name and contact information for three (3) references (New Jersey clients only) for which your firm has provided services similar to those requested.

## 2.3 ASSET MANAGEMENT SERVICES

The University has issued a request for proposals relating to investment services separately from this request. In connection with those services we would like to understand the processes you have in place to facilitate the movement of funds to and from an investment manager not affiliated with your institution and any fees related to this process.

## 2.4 OTHER SERVICES REQUIRED

Please describe your experience providing financing for equipment or long term leasing options to governmental entities.

Detail your institution's expertise in providing flexible and cost effective financing options for various capital needs of governmental entities.

Please describe your institution's risk management services in support your client's existing programs and/or policies. The University defines risk management services as the practice of identifying potential risks in advance, analyzing them and recommending precautionary steps to reduce/curb the risk.

Indicate any additional services or activities that the Financial Institution is able to offer the University, its students, and/or employees.

Please include any additional financial services that may assist the University during the contract period.

#### 2.5 <u>OPTIONAL SERVICE — PROCUREMENT CARDS</u>

This service may be awarded by the University as part of the Banking Contract. The University reserves the right to issue this service to a third party, separate from the bank selected, or the selected bank's vendor.

The principle objective is to allow authorized personnel the ability to purchase small dollar supplies utilizing a merchant card.

The University has included the following minimum requirements which will enable us to evaluate the prospective vendor.

- a) Cardholders must have a dollar credit limit and a transaction spending limit based on a 15-day cycle.
- b) Vendor must provide a central invoice with a monthly statement to the University's Director of Procurement Services, and monthly transaction statements to the individual department cardholders.
- c) Vendor must provide the University with a detailed outline of the contact structure at your company, including the customer service group (with times available), on line approvals and services.
- d) The card must be used selectively for check cashing privileges or cash advances.
- e) Indicate any insurance warranties associated with utilizing the card.
- f) Indicate if the card can be designed to our specification i.e. incorporation of the University logo and tax exempt status.

- g) Indicate and explain any rebate offerings, i.e. cash back discount, no annual maintenance fee, etc.
- h) The prospective vendor must be able to integrate with the University's PeopleSoft/Oracle software and charge individual departments based on card assignments.

Please include any additional features or capabilities that your program can accommodate above and beyond the noted requirements. Please include an estimate of the time required to implement the program. Also, describe what assistance you can give on establishing procedures.

#### 2.6 ADDITIONAL WORK

- 3.1.1 Provide the firm name, address and the names, contact information (addresses, telephone and facsimile numbers and e-mail addresses), relevant experience and proposed roles of those individuals who will be directly responsible for serving the University on a day-to-day basis.
- 3.1.2 Provide a brief history of your firm, specifically discussing your firm's experience with higher education. Explain why your company is best qualified to manage our program and would be the best partner for us at this time.
- 3.1.3 Provide a list of all clients lost within the last three years which includes:
  - a) A contact name and telephone number
  - b) Length of service at the account
  - c) Reason for the loss
- 3.1.4 Describe any pending, concluded or threatened litigation, administrative proceedings or federal or state investigations or audits, subpoenas or other information requests of or involving your firm or owners, principals or employees of your firm for the past five (5) years. Describe the nature and status of the matter and the resolution, if concluded. List any sanctions or penalties brought against your firm or any of its personnel (including suspension or debarment) imposed on your firm or any of its personnel by any regulatory or licensing agencies. Please include a description of the reasons for the sanction or penalties and whether such sanctions or penalties are subject to appeal. Please describe any potential conflict that may affect your service to the University.
- 3.1.5 Describe your firm's policy relative to the prohibition of discriminatory employment practices, affirmative action and equal opportunity and note the minority and female participating employees would serve the University.

- 3.1.6 Provide all information as detailed in Section 5. Financial Proposal of this RFP.
- 3.1.7 Provide all Forms and Attachments as detailed in Section 4.3.1 of this RFP.
- 3.1.8 Oral Presentation Agencies who submit a proposal in response to this RFP may be required to give an oral presentation of their proposal to representatives of the University. This will provide an opportunity for the agency to clarify or elaborate on the proposal but in no way change the bidder's original proposal.

# 4. BID PROPOSAL PREPARATION AND SUBMISSION

#### 4.1 GENERAL

The bidder is advised to read and follow all instruction contained in the RFP, and subsequent Addendums, in preparing and submitting its bid proposal.

Note: Bid Proposals shall not contain URLs (Uniform Resource Locators, i.e. the global address of documents and other resources on the World Wide Web) or web addresses. Inasmuch as the web contains dynamically changing content, inclusion of a URL or web address in a bid response is indicative of potentially changing information. Inclusion of a URL or web address in a bid response in a bid response implies that bid proposal's content changes as the reference web pages change.

#### 4.2 BID PROPOSAL DELIVERY AND IDENTIFICATION

In order to be considered for award, the bid proposal must be received by Procurement Services at the appropriate location by the required time in a sealed envelope as per Section 1.3.2. The date and time is indicated on the cover sheet.

# 5. SPECIAL TERMS AND CONDITIONS

### 5.1 COMPLIANCE WITH STATE BANKING STATUTE

The Financial Institution shall provide the University with assurance of its compliance with the provisions of N.J.S.A. 17:9A-4.1, concerning the security of all deposits made by State Colleges and Universities in excess of the amounts insured by the Federal Deposit Insurance Corporation or by any other Federal agency.

#### 5.2 BRANCH LOCATION

The University requires a Financial Institution with a local branch in close proximity and brief travel time from its main campus. Therefore, the successful proposer must have at least one full-service branch office located within close proximity to the University's main campus.

#### 5.3 IMMEDIATE TERMINATION PROVISIONS

The University may terminate the contract if any of the following events occur:

a. The bank is insolvent and is in the process of losing its charter.

b. Bank charges have increased in excess of the terms of the proposal as submitted by the Financial Institution.

c. The bank has been officially reprimanded by the New Jersey Department of Banking or any federal agency for its business practices.

d. The Federal Deposit Insurance Corporation (FDIC) has notified the bank of its termination of coverage.

e. The bank no longer is in compliance with the provisions of N.J.S.A. 17:9A-41 and N.J.A.C. 3:1-4.1 and, therefore, funds in excess FDIC coverage are no longer collateralized.

The Financial Institution is required to inform the University in writing in the event of any such occurrence.


#### **USEFUL DEFINITIONS for the purposes of Chapter 51 and Executive Order 117**

- **"Business Entity/Vendor"** means any natural or legal person, business corporation, professional services corporation, limited liability company, partnership, limited partnership, business trust, association or any other legal commercial entity organized under the laws of New Jersey or any other state or foreign jurisdiction. The definition also includes (i) if a business entity is a for-profit corporation, any officer of the corporation and any other person or business entity that owns or controls 10% or more of the stock of the corporation; (ii) if a business entity is a professional corporation, any shareholder or officer; (iii) if a business entity is a general partnership, limited partnership or limited liability partnership, any partner; (iv) if a business entity is a sole proprietorship, the proprietor; (v) if the business entity is any other form of entity organized under the laws of New Jersey or any other state or foreign jurisdiction, any principal, officer or partner thereof; (vi) any subsidiaries directly or indirectly controlled by the business entity; (vii) any political organization organized under 26 U.S.C.A. § 527 that is directly or indirectly controlled by the business entity, other than a candidate committee, election fund, or political party committee; and (viii) with respect to an individual who is included within the definition of "business entity," that individual's civil union partner and any child residing with that person. **1**
- "Officer" means a president, vice president with senior management responsibility, secretary, treasurer, chief executive officer or chief financial officer of a corporation or any person routinely performing such functions for a corporation. Please note that officers of non-profit entities are excluded from this definition.
- "Partner" means one of two or more natural persons or other entities, including a corporation, who or which are joint
  owners of and carry on a business for profit, and which business is organized under the laws of this State or any other state
  or foreign jurisdiction, as a general partnership, limited partnership, limited liability partnership, limited liability company,
  limited partnership association, or other such form of business organization.

<sup>1</sup>Contributions made by a spouse, civil union partner or resident child to a candidate for whom the contributor is eligible to vote or to a political party committee within whose jurisdiction the contributor resides are permitted.

- **"In-kind Contribution"** means a contribution of goods or services received by a candidate committee, joint candidates committee, political committee, continuing political committee, political party committee, or legislative leadership committee, which contribution is paid for by a person or entity other than the recipient committee, but does not include services provided without compensation by an individual volunteering a part of or all of his or her time on behalf of a candidate or committee.
- "Continuing Political Committee" includes any group of two or more persons acting jointly, or any corporation, partnership, or any other incorporated or unincorporated association, including a political club, political action committee, civic association or other organization, which in any calendar year contributes or expects to contribute at least \$4,300 to aid or promote the candidacy of an individual, or the candidacies of individuals, for elective public office, or the passage or defeat of a public questions, and which may be expected to make contributions toward such aid or promotion or passage or defeat during a subsequent election, provided that the group, corporation, partnership, association or other organization has been determined by the Commission to be a continuing political committee in accordance with N.J.S.A. 19:44A-8(b).
- **"Candidate Committee"** means a committee established by a candidate pursuant to <u>N.J.S.A.</u> 19:44A-9(a), for the purpose of receiving contributions and making expenditures.
- "State Political Party Committee" means a committee organized pursuant to N.J.S.A. 19:5-4.
- "County Political Party Committee" means a committee organized pursuant to N.J.S.A. 19:5-3.
- "Municipal Political Party Committee" means a committee organized pursuant to N.J.S.A. 19:5-2.
- "Legislative Leadership Committee" means a committee established, authorized to be established, or designated by the President of the Senate, the Minority Leader of the Senate, the Speaker of the General Assembly, or the Minority Leader of the General Assembly pursuant to <u>N.J.S.A.</u> 19:44A-10.1 for the purpose of receiving contributions and making expenditures.
- "Political Party Committee" means:
  - 1. The State committee of a political party, as organized pursuant to N.J.S.A. 19:5-4;
  - 2. Any county committee of a political party, as organized pursuant to N.J.S.A. 19:5-3; or
