### WORKS IN PROGRESS

An essay outlining the need for a more integrated approach for understanding contemporary immigrant politics. Using findings from the book I highlight the limits of a political-economic

model while demonstrating how an analysis of symbolic politics can improve our understanding of resource mobilization and contestation (in preparation for submission to *Sociological Forum*).

A comparative analysis of Spanish and English language media coverage of issues related to illegal immigration. The primary focus is on comparing both visual imagery and the narrative framing of salient events such as political protests (in preparation for submission to *International Migration Review*).

Paper on the importance of future oriented narratives for constructing political discourse. Using findings from the book I highlight how future imaginaries shape political contingencies (in preparation for submission to *Poetics*).

Research grant proposal to fund a pilot study of census data, targeted ethnographies, and surveys to identify specific immigrant-ethnic communities for in-depth study. The study will focus on processes of group and institutional conflict, accommodation, and adaptation in and around areas in transition to a more diverse racial/ethnic population (research grant proposal for submission to Russell Sage, AP Sloan, Mellon and National Science Foundations).
