As per the NJDOE, there are two ways to meet the basic skills requirement:

1. **Pass a Commissioner-approved assessment of basic skills.** Currently, the only approved assessment<sup>1</sup> is the [Praxis Core Academic Skills](#) with passing scores as follows: Reading: 156, Math: 150, Writing: 162.
2. **Demonstrate a score on the SAT, ACT, or GRE at or above the cut score for the year in which the exam was taken** (*see cut scores below*). The following conditions apply:
  - A CEAS educator preparation program may determine the evidence required to demonstrate a candidate's score on an exam.
  - CE candidates are responsible for ensuring official test scores are sent to the New Jersey Department of Education by providing the score report in a sealed, stamped envelope from the testing agency or having the score report sent directly from the testing agency.
  - The New Jersey Department of Education will accept the highest score on each test section, regardless of test date.
