PROGRAM STRUCTURE

The program will consist of 11 interdisciplinary courses known as the common core for all business disciplines (33 credits), seven specialization courses (21 credits), and up to two elective courses (6 credits). *The MCCC A.S. in Business Administration is designed for those students who desire to transfer to a baccalaureate program in business.*
