## TITLE IX IS A FEDERAL CIVIL RIGHTS LAW AND PROVIDES THAT...

*"No person in the United States shall, on the basis of sex, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any education program or activity receiving Federal financial assistance."*



## REPORTING POSSIBLE TITLE IX VIOLATIONS

Persons who wish to report possible Title IX violations have options:

- Notify a designated Deputy Coordinator or Title IX Coordinator.
- Contact the NJCU Public Safety Department.

While the University encourages reporting to both, the choice belongs to each individual, as does the decision about whether to file criminal charges.
